

Pre-Departure Checklist

Eligibility Criteria



Be fully-vaccinated with WHO-EUL vaccines*
(e.g. Pfizer BioNTech/Comirnaty, Moderna, AstraZeneca)

Vaccination certificate stating:



The traveller's name, and at least one other personal identifier such as date of birth or passport number



Country/region of vaccination which must be either Singapore or a Vaccinated Travel Lane (VTL) country/region



Name of vaccine used



Dates of vaccination



A QR code that can be digitally authenticated by immigration authorities



Been in Australia or any other VTL (Vaccinated Travel Lane) country for the last 14 consecutive days before departure to Singapore

*An individual is considered fully vaccinated 14 days after he/she has received the full regimen of a WHO-EUL vaccine

**VTP applications are to be made on the Safe Travel Office (STO) portal found on https://safetravel.ica.gov.sg/apply-now

***Travellers without smartphones may rent a device installed with the TT app from Changi Recommends. Children aged 7–12 yrs or travellers with special needs are eligible to use a TraceTogether token (which requires a \$\$50 refundable deposit per token) in lieu of the app which can also be collected at selected Changi Recommends counters. Actions Required



Apply for a Vaccinated Travel Pass (VTP) 3 to 60 days in advance of intended date of departure**
Non-vaccinated children aged 12 and below are allowed to travel to SG and do not need to apply for a VTP



Book a ticket on designated VTL flights Short-term visitors on non-VTL flights who are not



Short-term visitors on non-VTL flights who are not Singapore citizens/permanent residents will be denied entry into Singapore

Take a pre-departure test within 48 hours prior to departure from an internationally accredited or NATA (National Association of Testing Authorities) recognised laboratory, clinic or medical facility. The traveller's name, and at least one other personal identifier such as date of birth or passport number



A negative COVID-19 PCR test result, or negative professionally-administered rapid antigen test result

In Transit

Guidelines during travel:

- A face mask must be worn throughout the duration of your flight except when eating or drinking
- Observe your respective airline's advice regarding inflight rules and conduct of passengers

For more information on inflight safety measures, check with your respective airline.



Upon-Arrival



Purchasing of SGD and SIM cards to be done in transit area prior to clearing arrival immigration



Documents required to be shown to Immigration & Checkpoints Authority:

- A valid Vaccinated Travel Pass
- COVID-19 travel insurance
- TraceTogether app
- Vaccination certificate
- A valid pre-departure COVID-19 PCR test



Take on-arrival PCR Test and proceed immediately via private transportation, taxi or private hire car to your declared accommodation

Remain in isolation until you receive a negative test result (usually within 12–24 hours)

Post-Arrival

Testing requirements during your stay



All VTL travellers entering after 2 Dec need to undergo supervised self-administered Antigen Rapid Tests (ARTs) at quick test centres (QTCs) or combined test centres (CTCs) on Day 3 and Day 7 of their arrival into Singapore^



All VTL travellers entering after 6 Dec are also required to take a daily self-administered ART in addition to the supervised tests on Day 3 and Day 7. Travellers have to submit the results of their self-administered ART online using a link which will be sent to them via their declared contact details after arrival in Singapore. The self-administered kits can be purchased from most pharmacies and cost under SGD20



Travellers departing on the scheduled testing days are exempted from taking their ART on that day

Instructions for dates of the tests and appointment booking will be emailed to travellers upon their arrival into Singapore

^Cost of each supervised self-administered ART is SGD15, results within an hour

Regulations to note while out and about in Singapore:



Wear a face mask at all times



Adhere to prevailing rules regarding social gatherings (includes dining at F&B outlets)



Use TraceTogether app/token to check-in and out of establishments



Observe 1m social distancing



As some attractions are required to stagger entries as part of their Safe Management Measures (SMMs), it is recommended that entry to ticketed attractions be booked in advance



Keep TraceTogether app data for 21 days after leaving SG, to facilitate contract tracing and quick follow-up in the event of exposure to the virus



Before returning home, remember to check and abide by your airline and local government's prevailing entry requirements. E.g. take a pre-departure PCR test
